Regions "Thanks, Neighbor" Sweepstakes Official Rules

NO PURCHASE OR BANKING RELATIONSHIP NECESSARY. A PURCHASE, BANKING RELATIONSHIP OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

Overview: The Regions "Thanks, Neighbor" Sweepstakes (the "Promotion") consists of a sweepstakes (the "Sweepstakes") and an instant win game (the "Instant Win Game"). There are ninety-eight (98) Regions Bank branches (each a "Participating Branch") participating in the Sweepstakes. There is no obligation to have a Regions account or a Regions account at any of the Participating Branches to participate. See Appendix A for a complete list of Participating Branches. There will be one (1) Sweepstakes Grand Prize awarded for each Participating Branch.

1. Eligibility: The Promotion is open only to legal residents of Alabama, Florida, Georgia, Indiana, Louisiana, Missouri, North Carolina, South Carolina, Tennessee, and Texas who are at least eighteen (18) years old at the time of entry. Employees of Regions Bank, Merkle Inc., and their parent and affiliate companies, suppliers as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. 3. Timing: The Promotion begins on April 15, 2024 at 12:00 a.m. Eastern Time ("ET") and ends on July 15, 2024 at 11:59 p.m. ET (the "Promotion Period"). Administrator's computer is the official time-keeping device for this Promotion.

4. How to Enter: During the Promotion Period, visit https://welcome.regions.com,* follow the instructions to accurately complete and submit the registration form, including your first and last name (initials only are not sufficient), a valid email address, and home address (P.O. Boxes are not permitted). Next, select a Participating Branch from a drop-down menu provided. There is no requirement to have a Regions bank account or an account at the selected Participating Branch. You must reside in the same state as the Participating Branch you selected. Upon registering, you will automatically receive one (1) entry into the Sweepstakes prize pool associated with the selected Participating Branch. After you've registered, follow the instructions to answer the provided polling question(s). Next, you will advance to the Instant Win Game page and receive one (1) Instant Win Game play for that day. Once on the Instant Win Game page, follow the links and instructions to play the Instant Win Game. The Instant Win Game results will be instantly displayed. Potential winners of the Instant Win Game will be provided directions for validation. All potential winners are subject to verification before any prize will be awarded. Administrator is responsible for the functionality of the Instant Win Game. If you play the Instant Win Game and receive a "lose" message, meaning you are not a potential winner of an Instant Win Game prize, you will, however, receive one (1) bonus entry into the Sweepstakes prize pool associated with the Participating Branch you selected.

After registering, on each day that you log in to <u>https://welcome.regions.com</u> during the Promotion Period, you will receive one (1) entry into the Sweepstakes prize pool associated with the selected Participating Branch and receive one (1) Instant Win Game play.

* If you choose to enter using a mobile device, standard message and data rates apply in accordance with your personal mobile service plan. Check details of your plan prior to using a mobile device to enter. A mobile device is not required to enter.

Limit: You may register for the Promotion only one (1) time during the Promotion Period, and your registration must be associated with only one (1) Participating Branch. Sweepstakes/Instant Win Game: Administrator is an independent judging organization whose decisions as to the administration and operation of the Promotion and the selection of potential winners are final and binding in all matters related to the Promotion. <u>Sweepstakes</u>: Administrator will randomly select the potential Sweepstakes Grand Prize winners from all eligible entries received for each respective Participating Branch prize pool during the Promotion Period, on or around July 16, 2024. <u>Instant Win Game</u>: Four hundred fifty-five (455) random, computer-seeded winning times, one for each Instant Win Game First Prize, will be generated and seeded during the Promotion Period. If you are the first player to play the Instant Win Game First Prize, subject to verification of potential winner's eligibility and the household prize limitations. Only the first eligible entrant from a household to receive an on-screen notification of winning an Instant Win prize will be eligible to win the prize.

6. Disputes: Except where prohibited, entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Promotion or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the Eastern District of Michigan (Southern Division) or the appropriate Michigan State Court located in Oakland County, Michigan; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Promotion, but in no event attorneys' fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
